

Welcome Aboard Luxus Charters

Rules & Safety Instructions

Please take a few moments to read the following guidelines that are applicable while you and your party are participating in a charter:

1. Follow all directions from the crew regarding safety, emergencies, orderly behavior, loading, and unloading procedures.
2. Do not tamper with safety or life saving equipment.
3. Do not litter, including throwing objects on the yacht or overboard.
4. Use of weapons, illegal drugs is strictly prohibited on board.
5. No use of open flame or engagement in any actions that may be hazardous to others.
6. Smoking is prohibited anywhere on or within the yacht.
7. Consuming alcohol is prohibited anywhere on or within the yacht without a permit.
8. Dress appropriately and avoid high heeled footwear for comfortable walk onboard.
9. No destruction, defacement, damage, or theft to any personal or any company property aboard the yacht.
10. Do not leave any item or personal belongings/equipments unattended onboard.
11. Any vandalism or theft will be reported to the appropriate authorities.
12. Remain in areas designated for guests, do not enter any unauthorized area.
13. Yacht Staff are your points on contact for any sort of assistance on the yacht.
14. Crew members are obligated to report violations of any rules, regulations, procedures, codes of conduct, etc., to the appropriate authorities.

The Charterer should carry independent insurance for Personal Effects whilst on board or ashore for any Medical or Accident expenses (including emergency transport evacuation) incurred. The Charterer shall remain liable for any loss, damage, or liabilities.

Force Majeure: There will be no compensation paid to the party by Luxus (A-Line Yachts) if we have to cancel or change your yacht charter in any way because of war, riot, industrial dispute, civil commotion, blockade, invasion, explosion, sabotage, collision, grounding, terrorist activity, strikes, lock-outs or other labor disputes, governmental act or regulation, fire, natural or nuclear disaster, adverse weather conditions, storm, fog, major mechanical or electrical breakdown beyond the crew's control or other unforeseen circumstances that may amount to force majeure.

We do not accept responsibility if the fault is caused by you or any member of your party, an unconnected third party or an event which we or our supplier could not with due care have foreseen or avoided.

We reserve the right in our absolute discretion to terminate without further notice the yacht charter arrangements of any client who refuses to comply with the instructions or orders of the company staff, agent or other responsible person whose behavior in their opinions is likely to cause distress, damage, danger or annoyance to other customers, staff, any third party or to property. Upon such termination our responsibility for your charter ceases and we shall not be liable for any extra costs incurred by you.

Luxus (A-Line yachts) Charters will not be held responsible for any accidents, injuries, property damage, or death that may occur while participating in any activity associated with Luxus (A-Line yachts) Charters. All clients participate at their own risk and agree to hold harmless the Luxus (A-Line yachts) Charters team and persons connected directly or indirectly with the charter service. Furthermore, these parties are exempt from any injuries, damages, or liability suffered to any participant, entrant, captains, the party, their guests or companions, vessel, or equipment, which may occur during the course of the charter. Furthermore, the party agrees to abide by all local, state, and national federal and boating laws and regulations while participating in the charter
